
## Prosper Portfolio Highlights (at time of origination)\*



Cumulative Gross Loss Per Origination Dollar (%)

Cumulative Gross Loss Per Origination Dollar measures the cumulative principal charged off<sup>+</sup> for a given vintage, divided by the total principal originated in that vintage. "Gross" refers to the fact that losses shown do not account for the post-chargeoff recovery effort that Prosper conducts on behalf of investors. Currently, investors are receiving 7-10% of chargeoff principal as a result of recovery operations. There can be no guarantee that these recovery rates will remain the same in the future.






